New foundation governor, Liz Lephard was welcomed and introduced.

16/12 Apologies for Absence

Apologies were received and accepted from Mrs Cawood.

17/12 Co-operative Trust

Belinda Wardle gave details of the SHINE Partnership schools which are intending to form a Co-Operative trust. Of the twelve SHINE schools, eight have voted to go to consultation which will take place 9 January - 6 February. Heaton St Barnabas' is welcome to join the Trust as an Associate Partner and is therefore invited to take part in the consultation. Associate Partner status would entitle Heaton St Barnabas' to have one member on the Trust Board (full members have two representatives).

7.31pm Mr Grant entered the meeting

SHINE has chosen the Co-operative Trust model for various reasons including:

- no external sponsor
- all stakeholders have a voice
- commitment to engagement of the community
- strength in numbers, now over 600 UK Trust schools plus international links
- good support from the Co-operative College (for CPD etc)

The following points were raised during the Q&A session:

- The SHINE partnership will continue to operate with all twelve schools
- The Governing Body will elect a Board member, it should also be possible to nominate a second person to attend as an observer
- A stakeholder's forum will feed into the Trust
- Academies (eg Whetley) cannot be part of the Trust as they are already trusts
- Schools will buy into central Trust services etc, and costs will be scaled according to the size of the school
- Only full members will pay legal costs
- In the long term it is envisaged there will be links to higher education providers
- The Trust Board will meet at least once per term
- As an associate partner it would be easy to leave the Trust if required

The Governing Body **agreed in principle** to becoming an Associate Partner of the Trust and proceeding with consultation, **proposed** by Mrs Allan, **seconded** by Mr Grant and **unanimously approved** by the Governing Body.
